1. **Kelsey Christensen called the meeting to order at 12:00 p.m.**
2. **Present:** Colleen Nordin, Eric Habetler, Kim Bridenhagen, Judge David Weber, Joe Krebsbach, Sara Siefert, Donna Altepeter, Steve Seyfer, Shannon Viel, Lisa Barnaby, Tammy Sternard, and Kelsey Christensen.
3. **Adopt Agenda for this meeting:** Motion by D. Altepeter, second by C. Nordin to adopt the agenda. Motion carried by unanimous voice vote.
4. **Approve Minutes from Last meeting: December 17, 2021**
Motion by J. Krebsbach, second by J. Campbell to approve minutes. Motion carried by unanimous voice vote.
5. **New Business:**
 - a. **Manual and Program Contract Updates:**
K. Christensen informed committee that S. Seyfer and K. Christensen looking at manual updates and bring those to committee for review.
 - b. **Site visit to another county's Treatment Court:**
Committee agreed that this would be a good idea. Judge Weber to initiate the contact with Brown County.
 - c. **Coordinator's Role and More CCS Involvement with Participants:**
J. Krebsbach informed the committee that coordinator's role has grown larger than anticipated. He is looking at a way to bring in more case management support for participants. Committee supported the discussion.
 - d. **Narcan Distribution to Program Participants in Conjunction with Jail's New Program:**
T. Sternard informed the committee that jail was approved for a grant that would give Narcan to inmates with substance use disorder upon release. Jail recognizes that individuals with a substance use disorder are at the highest risk to overdose upon release. Committee discussed providing Narcan to Treatment Court clients. K. Christensen to look into Narcan availability to be provided to Treatment Court clients at intake.
 - e. **Program Capacity and Goal for 2022:**
Committee determined that they would revisit this at a later date.
